

Neither Snow nor Sleet Could Keep Attendees Away from the 2016 Kitchen Tour

Neither snow nor rain (nor sleet, nor freezing rain, etc.) could keep as many as 700 attendees from enjoying the 2016 *Heart* of the Home® Kitchen Tour on April 9. The weather may have been less than perfect – and certainly not what one would expect for an April day! – but it made for a cozy day of design inspiration and food sampling for the 11^{th} Tour the League has hosted since 2004.

Approximately half of respondents in an exit survey said they were planning an upcoming renovation in their home, and those looking for ideas were not disappointed. 16 kitchens were on the Tour, whittled down from more than 30 designer submissions, and each abounded with unique touches. One Signature Construction & Design kitchen included handfinished cabinetry from a cabinet-maker flown in from Miami for the job, along with a 12-foot center island counter made from a single slab of European walnut. A Giorgi Kitchens & Designs kitchen was a tapestry of textures, giving Tour-goers a look at three different counter treatments in one space, including polished granite, leathered granite, and butcher block, as well as several different cabinet finishes. And a Kitchens by Design renovation redefined "galley kitchen" with sleek, European-inspired design, a layout that maximized fabulous views, and a breakfast nook complete with a built-in espresso machine.

Another great idea on the Tour included backsplashes installed vertically, or in other atypical patterns, such as a herringbone in one Waterbury Kitchen and Bath space. A stamped stainless-steel backsplash surrounding the range in a Holcomb Cabinetry kitchen, both gorgeous and easy to clean. Home chef inspired must-haves that Tour goers took note of included the pot-filler faucet installed above a gourmet range in one Kitchen Gallery space, built-in ice makers, paper-towel nooks, and even a special cabinet designed raise the dishwasher, and save the dish washer's back.

More inspiration came from creative storage solutions for both kitchen and family in a space designed by Timeless by Kate. Horizontally-oriented handles in a BW Design Group kitchen gave cabinets there a unique look. Design Solutions used weathered wood-look porcelain tile for the floor of a bright, beachy kitchen. Designer Susan Komins featured her daughter's kitchen on the Tour this year, with glamorous touches including a mirrored backsplash and imported Lacanche range. Sustainer Patty Seif opened her own kitchen for the Tour. Renovated by Avalon, NJ-based Complete Interiors, the kitchen takes inspiration from its water view, literally on the banks of the Brandywine River.

Nearly a third of Tour goers have been on two or more Tours, and one thing that keeps them coming back is the fabulous food. It is never too early for ice cream, and cool treats from Caffe Gelato kicked off the day in one Newark home, and Tastefully Simple served butterscotch breakfast bread in another Newark location. De La Coeur Café included breakfast-y selections such as cinnamon sugar donuts and cinnamon buns among its sweet offerings, which also included linzer cookies, chocolate mousse cups, and more. Y'or So Sweet Creperie offered sweet and savory crepes throughout the morning in one





Once lunch time rolled around, hungry attendees were treated to apple bourbon pulled pork sliders from 2 Fat Guys, Korean pork tacos from Ulysses Gastro Pub, and coconut chicken soup from 8th & Union. Additional savory options included tangy tuna ceviche from Two Stones Pub, a selection of tea sandwiches from Bixby's Caterers, a zesty bruschetta from Out of the Ordinary Catering, and a "Deconstructed BLT" from The Gables: toast with bacon marmalade and a sprinkling of lettuce and tomato. The Culinary School of the Food Bank of Delaware showcased a seafood salad with cusabi aioli, and Healthy Foods for Healthy Kids demonstrated a rainbow vegetable stir-

fry. A signature salad and tomato pie from Bella Vista Trattoria and tomato pie from Cantina di Napoli hit the spot if you were in the mood for Italian. And, it may have been dreary outside, but it was spring inside with Toscana Catering's English pea and goat cheese ravioli.

The Melting Pot served dessert all day, in the form of chocolate fondue fountains with strawberries, Oreos, and graham cracker crusted marshmallows for dipping, and Sweet Magnolia Bakery offered a selection of cupcake shooters. Coffee selections from Brew Ha Ha!, tea from Levitea, and espresso drinks from Kitchen Kapers put pep in attendees' steps all day long, and a selection of chips and pretzels from Herr's made for great snacking between houses.

Recipe courtesy of Kitchen Tour Demo participant De La Couer Café. A fun dessert to share with the prosecco -- perfect for a summer dessert and you can turn the bubbly into a cocktail with lemoncello or framboise!

Dough:

1 1/2 sticks of butter 2 cups of flour 1/4 cup brown sugar 1/2 cup confectioners sugar 1/4 teaspoon salt

Whip butter and sugars together until light and fluffy. Add salt and flour and mix until barely incorporated. Will look dry. Press dough with your fingers or the bottom of a measuring cup into a 9 by 13 baking pan that has been greased and floured.

Filling:

4 whole eggs 2 egg yolks 2 cups of sugar 1/3 cup of flour 1 teaspoon lemon zest 1 cup fresh lemon juice

Mix all ingredients and pour over dough. Bake at 375 until edges begin to bubble, about 15-20 minutes. Let cool completely. Cut and sprinkle with additional confectioners sugar. Enjoy!

Advocating for Erin's Law

Erin's Law is almost ready for full Senate consideration, thanks to a work session with interested parties led by Sen. Henry, left, and Sen. Lopez in Wilmington. Thank you to all of the ladies who joined us in Dover prior to that meeting to speak to and support Erin's Law (SB213)! Our presence definitely showed how serious we are about this legislation and that we are truly a force! A huge thank you to the task force and JLW members who were unable to attend but showed their support with a letter or testimonial, collecting letters of support from friends and family, or sending best wishes!

The bill has been tabled for now because there is some opposition from the Department of Education (DOE) and School Board regarding curriculum regulations; the Office of Child Advocates supports the legislation but would like to



see child abuse related legislation be amended and consolidated under the same section of the code for more consistency and efficiency in how these activities are regulated; and the Beau Biden Foundation (BBF) and Prevent Child Abuse DE (PCAD) strongly supports Erin's Law but feels the legislation should be expanded to cover all forms of child abuse and neglect. Although there were a few positions of opposition from various organizations, everyone expressed their support of the intended legislation and would like to work collaboratively to amend it so that it is mutually beneficial to all stakeholders without compromising the integrity of what the law seeks to accomplish.

Senator Lopez (one of the lead sponsors and Senate Education Committee member) is going to coordinate a meeting with the stakeholders so that we can work together to develop suitable legislation that addresses everyone's concerns. He still wants to get this passed by the end of session so this will require a lot of quick coordination as session ends on 6/30. To quote Patty Day Lewis from yesterday's hearing "THIS WILL GET DONE".

Patty Day Lewis also mentioned, on record, that she will find the funding to pay for the curriculum, which is a plus. There was also offline conversation with Patty about the League making a financial contribution toward the funding program curriculum and also providing Stewards of Children (BBF's signature training program) training to League members.

During the hearing, the JLW also received thanks and recognition from the Office of Child Advocates, BBF, and PCAD for spearheading this legislation in Delaware which shows, on record, our leadership in this.

So with all of that being said, we still have some work to do but the willingness for parties to collaborate brings another level of optimism for this legislation.

Erin's Law is named after childhood sexual assault survivor, author, speaker and activist Erin Merryn.

"Erin's Law" requires that all public schools in each state implement a prevention-oriented child sexual abuse program which teaches:

- Students in grades preK 12th grade, age-appropriate techniques to recognize child sexual abuse and tell a trusted adult
- 2. School personnel all about child sexual abuse
- 3. Parents & guardians the warning signs of child sexual abuse, plus needed assistance, referral or resource information to support sexually abused children and their families

The 94th Annual Conference of The Association of Junior Leagues International Celebrates the Power of Women as Volunteers

On Wednesday, May 11, through Sunday,

May 15, Christi Miller and I had the pleasure to travel to Atlanta, GA to represent the Junior League of Wilmington (JLW) at the annual meeting of the Association of Junior Leagues International (AJLI). Christi was a great travel partner, and even though we had a few hiccups getting on the plane (i.e. Christi having some nerves about leaving her adorable 1 ½ year old son for the first time and me trying to make it through security with a mini-Delaware flag in my carry-on bag which got "flagged" by TSA as a weapon), we did finally board our plane and made it safely to Atlanta!

Christi and I were both newcomers to the conference, but after speaking to some of the past

attendees, we knew we were going to have a great time getting to know one another better and soaking up a lot of information to bring back to our League. One of the great perks of the annual conference is that you not only get to check out a great city but you get to network with other ladies in different Leagues across the country and in different parts of the world, including Canada, Mexico and the UK! It is so encouraging and invigorating to hear what other Leagues are working on, the challenges they are facing and how they are partnering with their community to make a difference - and a difference we are making!

Like many of you, I read about the history of the JLW while I was a Provisional, and I was impressed! What was even more impressive was to see that our League was one of the early adopters across the country to organize a committee of women to run these types of charitable endeavors. And, being founded in 1918 earned us a front row seat to the 94th annual conference opening session with 291 Leagues worldwide represented.

The theme for this year's conference was ALL IN! This was AJLI's way of saying that the most powerful community impact strategy for any Junior League is leveraging all of its assets – including the commitment, knowledge and



expertise of its members – to achieve a lasting and positive impact on society. The annual conference differs from other AJLI meetings because the meeting focuses more on the business aspects of AJLI as well as celebrating all the accomplishments of the Leagues over the past year.

When Christi and I were not in business meetings, we attended different trainings and panel discussions to help hone our skills as future leaders. As president-elect, I attended a particularly interesting session on parliamentary procedures, which explored the basics of Robert's Rules of Order, which became especially helpful during the annual business meeting on Saturday when I represented the JLW as the voting delegate. It was truly fascinating to see the interworking's of an annual business meeting from how it is conducted, how a balanced debate is encouraged and to orderly decision-making.

And a big kudos to the Junior League of Atlanta (JLA) for doing a fabulous job of hosting their sister Leagues in their city. The conference's keynote speaker was Carlotta Walls LaNier who recounted her experience as the youngest member of the Little Rock Nine, a group of African-American students who, in a major breakthrough for civil rights, were the first black students ever to attend classes at Little Rock Central High School in Little Rock, Arkansas in 1957. In 1999, Ms. LaNier and the other members of the Little Rock Nine were awarded the Congressional Gold Medal - one of the nation's civilian honors by President Bill Clinton. All attendees received an autographed book by Ms. LaNier. To keep with the diversity and inclusion theme, later that evening, we went to the National Center for Civil and Human Rights for the opening night reception.

In addition to all of the great sessions, the JLA set up numerous excursions on Saturday afternoon for League members to attend. I had the pleasure of joining a shopping trip to Buckhead, which is Atlanta's version of Rodeo drive. That same evening, Christi & I attended the closing reception and awards banquet and celebration at our hotel, the Marriott Marquis. AJLI did a great job of making it a special event. Overall it was a fabulous conference and one of the many perks for future leaders of the League.

AJLI's New Membership Model & The JLW



This fall, the Junior League of Wilmington decided to blaze a new trail and signed on to be one of the first Leagues worldwide to implement AJLI's new Membership Model, which focuses on "transforming their membership experiences to foster lifelong, satisfied League members." This model, developed by AJLI over the course of 5 years, is designed to refocus our League's efforts and energy on members, providing greater flexibility, engagement, and networking within the League.

The new model focuses on three key values — member voice and choice, talent deployment, and member connections.

Each Active and Provisional member will complete a "Member Compact" annually, allowing each member to reflect on her League involvement and accom-

plishments from the past year as well as commit to goals and involvement in the League for the upcoming League year. Each Active and Provisional member will meet annually with a Member Advisor to discuss her goals, involvement, commitments, and skills as they relate to her JLW experience, including her committee placement interests. Rather than focusing on members completing a set number of requirements, our League will be more focused on what individual members choose to do rather than are required to do. Members will still be placed on a League committee and will commit to participate in several key League activities, specifically General Membership Meetings (GMM) and our annual fundraiser, and other involvement will be driven by the members' interests and goals.

In our pilot phase this spring, the Member Advisory and Nominating committees conducted 71 member interviews throughout March and April, representing over 90% of current Active and Provisional members. As a result of the interviews, we received rich feedback about members' experiences this year and captured their ideas for improving the League for the future.

When asked why the Junior League of Wilmington is her volunteer organization

of choice, a member shared "The Junior League of Wilmington is made up of women who are all focused in one direction and trying to make a difference by supporting young women in Wilmington." Another member stated that she loves the JLW because "We do everything: friends, events, community impact."

Members highlighted a variety of League events as the most meaningful or enjoyable parts of their 2015-16 experience, including the lively, engaging GMMs; the variety of social events such as the Red Party and Book Club; and the inaugural Women's Leadership Summit. Suggested improvements for the League in 2016-17 included adding more direct Community Service events at varied times throughout the week; providing training to improve our work with girls aged 12-18 in the greater Wilmington area; and considering diversity and inclusion to enhance members' awareness and engagement with each other and the community.

The Roll-Out team will continue to share updates at GMMs and through the Tuesday Tidbits. We look forward to creating an incredible membership experience that only strengthens our League and its accomplishments.
