### Erin's Law: A Bill Whose Time Has Come

"Erin's Law will give children a fighting chance, a voice, and the tools to help protect themselves. It should be passed in all 50 states. Common sense. It's as simple as that."

The Junior League of Wilmington is committed to community outreach and specifically, the betterment of lives of girls ages 12 to 18. These are critical years when young girls are moldable, teachable, but also vulnerable. With this being the focus, naturally JLW would get involved with efforts to pass Erin's Law in the state of Delaware. Since the beginning of the year, JLW members **Dionna Sargent, Susan Colby, Stephanie Graev**, et al have been working hard toward this most important initiative and ask that others follow their lead.

#### What is "Erin's Law"?

Erin's Law is an initiative named after childhood sexual assault survivor, and activist Erin Merryn. She is the founder and President of Erin's Law, which is registered with the State of Illinois and the IRS as a 501 (c) (4) non-profit social welfare organization.

Under Erin's Law, school districts would be mandated to educate students on sexual abuse. In addition, school boards will adopt age appropriate curriculum on sexual abuse education to students in grades pre-k through 12th grade. The sexual abuse curriculum will include:

- 1. A clear definition to students on sexual abuse and how to prevent becoming a victim. "How to Tell Today" & "How to Get Away"
- 2. Educating elementary level children on appropriate touches: safe and unsafe touches.
- 3. Educating elementary level children on safe and unsafe secrets and not allowing anyone to keep you silent.
- 4. Identifying safe people in children's lives they can talk to if someone touches them in an inappropriate manner.

#### Why is Erin's Law an important initiative?

Child sexual abuse has become an extremely prevalent social problem that has far-reaching, long term effects. Conservative reports have estimated that in today's society 1 in 4 girls and 1 in 6 boys will be sexually molested before they are 18 years old. Unfortunately, that means 1 in 5 of America's youth, or 20% to 25% of the population will become a victim. Most often, the perpetrator is a dear family friend, trusted adult (clergy, teacher, etc.), or even a close relative.

One of the insidious hallmarks of child sexual abuse is secrecy. It makes ripe an environment that destroys lives and families and sometimes creates a damaged psychology within its victims causing them to offend others. In many families, child sexual abuse becomes a culture that is carried out generationally, infecting the family bloodline for decades. The shame and secrecy haunts these families so intensely that many never speak of the taboo for fear of disgracing the family.

In many cases the victims of child sexual abuse turn their shame inward, simply perpetrating anger and guilt against themselves through a myriad of self-destructive, sabotaging behaviors. The tragedy is that this secrecy creates a dynamic where perpetrators are able to silently intimidate and remain hidden. Erin's Law is about ending the stigma and secrecy of child sexual abuse and shining a light on the problem so that offenders cannot thrive.

#### Has "Erin's Law" been effective?

Since its inception in 2010, Erin's Law has been extremely successful with more legislative work to be accomplished. To date, 26 states have passed the law. Eighteen states, including Delaware have introduced Erin's Law for legislation and in 6 states the bill is in process. In addition, innumerable lives have been positively impacted and empowered by this initiative.

### **Community Impact**

### Why should I get involved?

Child sexual abuse does not just impact the victim and his/her family. It is a growing social epidemic that affects society in many ways. Teenage pregnancy, human trafficking, teenage delinquency and many other social problems have their origins in child sexual abuse. It is such a devastating concern that the Center for Disease Control, in a recent study, estimates the lifetime cost to society for dealing with all of the resulting problems for just one year's worth of traumatized children is \$585 billion. This is a staggering figure by any measurement.

It is truly a matter of whether we as a society chose to address this problem proactively or reactively, but either way, we are and will have to address it in the future. Getting involved in the eradication of child sexual abuse, notwithstanding the societal consequences, is simply the right thing to do.

### How can I contribute in a meaningful way?

You may get involved in many ways. It is important to educate yourself about child sexual abuse so that you can identify the signs and know what to look for when dealing with children. If you have been a victim of child sexual abuse in the past, breaking the silence in your own life can be empowering and beneficial to others. Becoming a mentor and "safe place" for the young children in your sphere of influence can also prove impactful.

### Women's Leadership Summit

It was just a few short months ago when the JLW embarked on a brand new endeavor, the brainchild of current JLW President, Kristen McMullen. She had a vision to bring a oneday women's leadership summit to Delaware and called for JLW members to join her in forming a planning committee. A select few answered the call and the journey began. Their dedication and hard work culminated in the first "JLW Women's Leadership Summit 2016" which was appropriately themed, "Ready, Set, Lead!" About 85 current and emerging women leaders from the tri-state area ventured to the Executive Banquet and Conference Center in Newark on an unseasonably warm Saturday in February. They partook in a full day of sessions, networking, and a panel discussion all centered around leadership from a variety of perspectives.

The Summit was a comprehensive leadership development opportunity for women who were seeking to finetune their leadership skills and become better equipped to lead in their communities, organizations, and their lives. Summit attendees learned to live and work to their full potential, developed strategic plans for their careers, discovered how to master difficult conversations, and how to effectively brand themselves, from other women who have made their

marks professionally.

There was something for everybody as both presenters and attendees represented for-profit enterprises, government, non-profit organizations, universities, entrepreneurship, women just entering the workforce, university students and the arts.

Some of the highlights of the day included a morning keynote address that featured Christiana Care Health System President and Chief Executive Officer, Dr. Janice E. Nevin. Dr. Nevin is leader of the largest health system in Delaware and was named among 100 Physician Leaders to Know in 2015 by Becker's Hospital Review. Dr. Nevin showed us that the path to happiness and a successful career is not necessarily straight and clear.

"It amazes me how JLW was able to get such high profile speakers including the CEO of Christiana Care Health System to donate their time on a Saturday and provide us with such useful and practical information. ### Are We Ready To Face A Crisis?

Natural and manmade disasters, riots, and acts of terrorism – these are not things that you want to think about nor are they things that you generally think a Junior League would need to entertain. The Leagues in Saint Louis, Baltimore, and Charleston never thought they would have to deal with major rioting and mass shootings, but they did.

At the AJLI Fall Leadership Conference, leaders from these three Leagues presented what their Leagues did in the face of crisis when none of them had a plan in place for how to handle these types of situations. The key takeaway was the importance of getting a "seat

at the table." Prior to a crisis situation, these Leagues found that when they reached out to help they were dismissed due to the fact that they had lost their recognition as a go-to organization. They also noted the importance of keeping members informed and communicating immediately even if they do not have a lot to say because silence can be seen as not caring and non-action.

The Junior League of Wilmington realized that it is in its best interest to have a detailed emergency response and communications plan. Using this as a perfect training opportunity, members were invited to learn about creating a crisis management plan

while helping construct a plan for the Junior League of Wilmington.

What came out of that training? The beginning of a crisis management plan. Training included who would serve on the crisis management team and the role they would play, crisis communication channels, and a list of community stakeholders that need to be engaged prior to and during a crisis.

The League hopes to never have the need to activate the crisis management plan however, the League is better prepared to face a situation should one arise.

### **Growing Our Community Impact**






In the coming months, members of the League will learn about issues facing teen girls in Wilmington and will determine which outcome areas the League will focus on in the coming years. We will work to educate our membership so that they can be advocates for our focus area and share our message. The fall Provisional class project started us on this journey and did an outstanding job.

### **Community Impact**

Dr. Martin Luther King Jr. was born on January 15, 1929, in Atlanta, Georgia. He is the most recognized figure of the U.S. Civil Rights Movement. King was also a Baptist Minister who headed the Southern Christian Leadership Conference (SCLC). He was crucial in ending legal segregation of African-American people in the South as well as the creation of the Civil Rights Act of 1964 and the Voting



Rights Act of 1965. King received the Nobel Peace Prize in 1964. King was assassinated in April 1968 while standing on the balcony of the Lorraine Motel in Memphis, Tennessee. He continues to be remembered as one of the most influential African-American leaders in history.

One of the ways he is remembered is by the annual nationwide Day of Service held in his honor. This year, Monday, January, 18, 2016 was an especially meaningful day and a historic first for members of the Junior League of Wilmington, Delaware (JLW). It was the first time that JLW observed and participated in the MLK Day of Service. The MLK Day of Service began in Philadelphia, PA in 1996 and quickly spread across this nation. As a form of commemoration for the iconic Civil Rights Leader, the MLK Day of Service is a day that would serve as a "day on" instead of a "day off."

It is a day of the year where Americans of all ages, races, and creeds unite in cities and towns across the nation to participate in community service activities addressing unmet human needs, advocacy, civil protests, parades, special programs and religious services. The key word being "unite" to honor the memory of Dr. King and all that were a part of the Civil Rights Movement in America.

The JLW partnered with the Wilmington Clothing Bank of Delaware this year. About 20 JLW and community volunteers worked together to sort, fold and hang approximately 6,000 pounds of donated clothing. The majority of the donated clothing will be given to Delaware's economically disadvantaged and homeless populations. A small remainder of the clothing will be shipped to developing nations.

Volunteers shared donuts and coffee while discussing the work of the Junior League in Wilmington's neighborhoods. "The day of service not only gave JLW members a chance to truly engage Greater Wilmington residents about issues affecting the city but also gave us an opportunity to educate them about our great work here. That experience was priceless", said JLW MLK Day of Service Organizer, Kia Booker.

The experience was so positive for one volunteer that she has chosen to become a part of JLW's next Provisional class while another served as a Session Speaker at the JLW Women's Leadership Summit. Overall, we can say that it was an amazing and successful day of service.

The JLW teamed up with DAPI (Delaware Adolescent Program Inc.) as two forces set out to improve the lives of the students who attend DAPI. Founded in 1969, DAPI is a facility for pregnant teens that provides a continuation of their education and the special care they need as expectant and new young parents. Mentoring and supporting services promoting empowerment and self-sufficiency help DAPIs students become

Last year, JLW worked to renovate the kitchen and the community room for DAPI. As space of solace and education, these updates are necessary for the DAPI community. As the physical updates come underway, the JLW plans other services to improve the lives of these students. An upcoming JLW project will be to put inspirational sayings and thoughts on the lockers, stairs and in the bathrooms in the DAPI facility. This effort is a means to inspire the students of DAPI and encourage them to fulfill their potential and ultimately create a positive environment.

#### The Impact of DAPI

DAPI works to "remove the stigma against teen pregnancy, mental health, and poverty and replaces it with selfesteem, development assets, coping skills, education, careers." In its 2014 Newsletter, DAPI reported that 67% of its graduates were accepted into college (a 34% increase to the previous year). DAPI also provides vocational programs for students that desire to enter the trade professions.

Lynn's closest friends are other women that she met through the League. Lynn's advice to other women considering the Junior League: Try It, Try Something different, Something out of your comfort zone. Try everything the League has to offer. You'll be glad you did.
